## **DUMPSTER ONSITE FOR BHA TENANTS ONLY**

### **SCHEDULED: JULY 14th, 15th, and 16th**

This cleanup is open **only to all residents of Bangor Housing**, so please bring **proof of residency** when dropping off items. A driver's license or ID with your name and address will be accepted. Without proper proof of residency, you will be turned away.

#### **Scheduled Dates & Times:**

- **Tuesday – July 14th:** 8:00 AM to 5 PM
- **Wednesday – July 15th:** 8:00 AM to 5 PM
- **Thursday – July 16th:** 8:00 AM to 3:00 PM (**LAST DAY and we stand firm on the 3pm**)

Extended hours on Tuesday and Wednesday are available for residents who work outside normal business hours. Please understand that we work closely with Casella Waste, and they do a great job to keep up. There may be a point in a day when the dumpster gets full, and we can't push it down any more than it is. You could be turned away until it is emptied.

#### **Free Disposal Opportunity**

If you have been holding onto items due to high landfill costs or limited trash capacity, this is your chance to dispose of them **FREE OF CHARGE**.

Please understand that providing onsite dumpsters is not something Bangor Housing is required to do. This is a privilege being offered to residents so we can help make disposal easier and more affordable. We ask that everyone respect the guidelines, staff instructions, and scheduled times so we can continue offering opportunities like this in the future.

Residents are encouraged to also clean up **outside areas around their apartments**.

Accepted items include:

- Mattresses
- Chairs
- Couches
- Bagged household items
- General household debris

A **separate dumpster** will be available for regular household trash.

## IMPORTANT REQUIREMENTS

- If someone is disposing of items **on your behalf**, they must be **present with you, OR provide:**
  - **Proof of your address**, and
  - A **signed letter from you** stating they are authorized to dispose of items for your residence, please add an active phone number.

## UNACCEPTABLE ITEMS

Due to Federal, State, and Local regulations, the following items are **NOT permitted**:

- Aerosol Cans
- Appliances
- Car Batteries
- Cell Phones
- Computers / Electronic Waste
- Explosives
- Fire Extinguishers
- Fluorescent Light Bulbs
- Hazardous Waste / Chemicals
- Lead
- Medical Waste
- Monitors
- Paint
- Propane Tanks
- Tires
- Yard Waste
- Batteries
- Microwaves
- Oil
- TVs

Bangor Housing maintenance staff **will not be available to assist** with transporting items to the dumpsters. Disposal is the **responsibility of each resident and done at your own risk**.
